Introduction

This document offers an inventory of resources, through provided links, that can be useful to counties, cities, towns, and others interested in developing more effective, inclusive, equitable, and sustaining capacities to bring the voices of the public into local health and health-related policymaking and other decisions. The resources provided here are in service to the purposes of the Community Voices for Health in Monroe County (CVHMC) initiative as well as responsive to comments from members of the public who have participated in CVHMC activities to date. A full table of contents for this document follows immediately below this Introduction section.

The resources identified in this document are organized into three categories around the themes of comprehensive plans, health in all policies, and public engagement.

The first set of documents is related to comprehensive plans and health. This set includes guidance documents that provide information about how comprehensive plans may best be organized to include health-related content, including health and health-related-focused chapters of such plans. Also found here are examples of adopted local comprehensive plans that have individual chapters on specific health-related matters. Finally, there are links in this section to excerpts of health-related content from a few county and city comprehensive plans throughout Indiana.

The second set of documents is focused on Health in All Policies (HiAP) materials. These include quidance documents to help communities understand and develop Health in All Policies strategies, resolutions and ordinances. Other documents here provide specific examples of adopted Health in All Policies resolutions and ordinances that promote attention to community health and social determinants of health and also support more informed and integrated health-related planning.

The third set of documents brings together informational guides as well as specific practice and policy examples to support the develop of more effective, inclusive, and equitable public engagement. Included here are adopted public engagement-related principles and ordinances that may help local officials and the public frame and guide effective public engagement practices over time.
